Banobras carries out the processing of your personal data, through the Project Information Directorate, in the exercise of its functions, based on the provisions of the General Organization Manual of Banobras, function 4 of section IX.4 "Project Information Directorate"; as well as the Specific Organization Manual Planning and Sustainability Strategy Unit, functions 1 and 2 of section 173200 "Promotion and Investor Relations Management".

TRANSFERS OF PERSONAL DATA

Personal data will not be processed for purposes other than those expressly stated in this privacy notice, nor will personal data be transferred to other responsible parties, public or private, that require the consent of the data subject.
